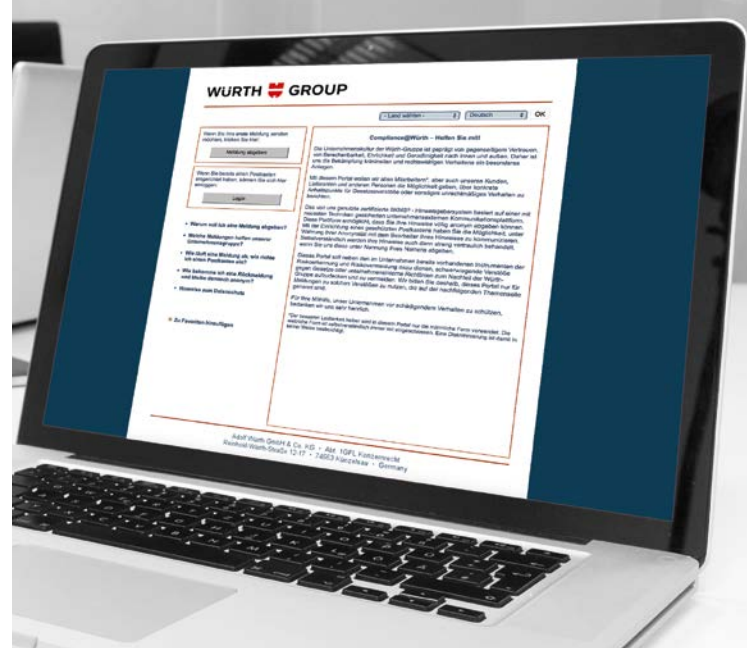

SPEAKUP REPORTING HOTLINE

Our **SpeakUp reporting hotline** allows you to report irregularities or even criminal acts maintaining your absolute anonymity.

By setting up a mailbox, the person reporting an incident can communicate with the responsible officer. When setting up your mailbox, your anonymity remains preserved.

The Compliance Officers in charge will handle all tips with strict confidentiality and in close coordination with the responsible company management.



CIVIL COURAGE

We expect all employees to comply with the laws and regulations.

Likewise, we expect that illegal or irregular actions not be tolerated. This includes reporting any misbehavior to the responsible offices. This is an expression of civil courage and the responsibility of all employees!
